THREE: Increasingly, the healthcare providers are using AI to compile, analyze, and send reports of vaccine injuries to the CDC. Therefore, everything depends on CODING—which codes are applied to patients’ harm and death. Code designations can be switched to conceal the truth.

Also, AI is trained on older erroneous and deceptive medical practices for determining vaccine injuries. So it can easily and routinely overlook actual vaccine-caused injuries and deaths.

FOUR: To complete this cozy relationship, on the CDC’s side imagine what would happen if the healthcare providers suddenly sent in a river of reports revealing injuries from MANY VACCINES. You see, the CDC buys billions of dollars of vaccines every year and distributes them for use. The CDC is going to admit they’ve been injuring and killing MANY Americans with these injections??

There are other reasons why the VSD is a phony set-up, but these are standouts.
